How to join

Full Members' Subscription (all figures for 2024)

Basic Subscription

The basic subscription is £6,952.32 + VAT, which covers membership of the FLA and membership of one division (Asset, Consumer or Motor).

Additional Divisional Subscription

Members can join more than one division by paying an additional fee of £3,476.16+ VAT per division.

Variable Subscription

The variable subscription for each member is calculated on their certified Net Book Value* for the appropriate year. This is the total amount of debt the member is expecting to receive from their loan book. The rate per £1m of Net Book Value is £15.49 plus VAT.

Any member with a Net Book Value of more than 1% of total members' Net Book Value will have all their Net Book Value in excess of the 1% figure discounted.
